What data do we collect?

When you submit a contact form on the website we collect the following information:

- Name
- Telephone number
- Email address

We ask for this information so that we can contact you.

Marketing

When you complete a contact form on our website you are given the option to opt in to receive occasional updates and offers from us. If you have ticked this box we will send you emails from time to time about concerts we think you may like. These will be concerts by the Piano Man and by artists that form part of our sister company, Show4U. We will not share your data with any third party. If you have agreed to receive marketing communications you may opt out at any time. You can do this by clicking the 'Unsubscribe' link which appears at the bottom of all our marketing emails or by contacting us.

What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete information you believe is incomplete.

The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
